#### From the East and West

- Leave the M54 at junction 5, signposted Telford Central
- Take the exit marked B5072, Hall Park Way, signposted Lawley
- Bear Right, up to the next island-turn at 3<sup>rd</sup> exit towards the retail parks
- Continue over the two-traffic islands passed all the retail outlets.
- At the third island turn right, and you will see the Wrekin Office on the left in 100m
- There is parking on the road, and visitor parking at the front.
